ELIGIBILITY

Only purebred Greyhounds are eligible for competition. All entries must be individually registered with the AKC, NGA, UKC or an AKC recognized foreign registry.

STAKES OFFERED

Open: Any eligible Greyhound, excluding ASFA Field Champions of Record, that has met certification requirements.

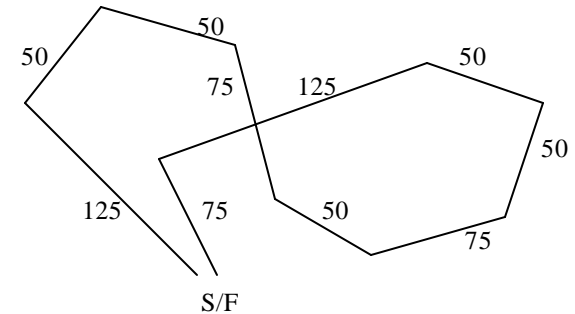
Field Champion: Any Greyhound ASFA Field Champion.

Veteran: Any eligible Greyhound whose age exceeds six years, who has met certification requirements.

CONDITIONS

- Hounds must be 1 year of age or older on the day of the trial.
- A stake will be split if 20 or more entries are present in any one stake at the time of the draw.
- All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and the entry fee refunded.
- Hounds not present at roll call will be scratched.
- Each entry will be examined at inspection for breed disqualifications.
- Spayed, neutered, cryptorchid, and monorchid hounds (without breed disqualifications) may be entered.
- Battery powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips and/or fur.
- The course will be reversed for the finals, and again for runoffs and Best of Breed.
- Exhibitors are requested to not bring bitches known to be in season to the field. A \$5.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$20.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
