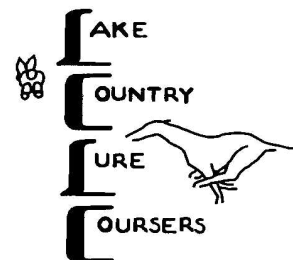

Note: Conformation judging times for Borzoi, Greyhounds, Deerhounds, Ridgebacks and Whippets will not conflict with the field trial. For other breeds, please advise us at or before roll call if you are entered in both events and anticipate a conflict, and we will do the best we can to accommodate you.

Entries will be acknowledged by email, **IF** a legible email address is provided. **Please allow extra time and postage for entries to cross the border.** Late, incomplete, unsigned or conditional entries will not be accepted.

ELIGIBILITY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughi, and Whippets are eligible for competition. All entries must be individually registered with the AKC, NGA, UKC, or an AKC recognized foreign registry, or possess a Critique Case number from the Saluki Club of America. Miscellaneous breeds: Chart Polski, Cirneco del Etna, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid. Limited and/or Provisional Stake entries shall be individually registered with the appropriate registry.

Breed disqualifications apply.

STAKES OFFERED

Open: Any eligible sighthound, excluding ASFA Field Champions of Record that has met certification requirements.

Field Champion: Any ASFA Field Champion.

Veteran: Any eligible hound whose age exceeds six years, except Irish Wolfhounds whose age shall exceed five years, and Whippets, whose age shall exceed 7 years, who has met certification requirements.

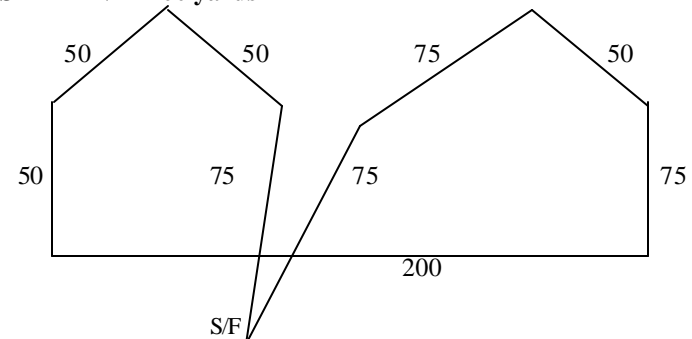
Limited stake: any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

BEST IN FIELD WILL BE OFFERED

CONDITIONS

- Hounds must be 1 year of age or older on the day of the trial.
- A stake will be split if 20 or more entries are present in any one stake at the time of the draw.
- All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
- Bitches in season, hounds with breed disqualifications and lame hounds will be excused and the entry fee refunded. Hounds not present at roll call will be scratched.
- Each entry will be examined at inspection for breed disqualifications. Spayed, neutered, cryptorchid, and monorchid hounds (without breed disqualifications) may be entered.
- Battery powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips.
- The course will be reversed for the finals, and again for runoffs and Best of Breed.
- Direction for Best in Field will be at the discretion of the judges.
- Exhibitors are requested to not bring bitches known to be in season to the field.
- A \$5.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$25.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.
