**Fort Niagara State Park is at the mouth of the Niagara River**

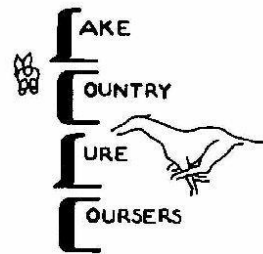
**From the Queenston - Lewiston Bridge** – bear right from customs. Exit at first right to Niagara Scenic Parkway north (formerly Robert Moses Parkway). Stay on Niagara Scenic Pkwy through Lewiston to route 93 (Youngstown). Turn left (west) onto route 93( Youngstown Lockport Rd). Ends at Niagara River. Turn right (north) onto Main Street to Fort Niagara State Park entrance. No entrance fees if before 10am. **Coursing field is beside a large man-made sledding hill on your right.**

**From Buffalo area, NY – From I-90 take** 190 North to Rte 265 north for a short distance to Rte 104 north – Niagara Scenic Parkway – formerly Robert Moses Parkway. Follow directions above.

**OTHER EVENTS** – Spend a little extra time and visit Historic Fort Niagara while you're here, it's the oldest continuously occupied fort in North America. More details her:

If you have entered two tests on the same day, you may run them at different times, or back-to-back (with a rest period in between).

Dogs entered in the CAT or FASTCAT test may wear a buckle collar (no tags), coursing blanket or muzzle at the owner's discretion to aid in the retrieval at the end of the course.

New Title rosettes for CATs

**Lake Country Lure Coursers** will offer small prizes for the fastest and slowest times in each FAST CAT test.

**The Dalmatian Club of the Finger Lakes** will offer a spotted New Title rosette to any Dalmatian earning a Coursing Ability title.

## ELIGIBILITY

**CAT Test** - The Coursing Ability Test is open to all breeds, and Canine Partners at least one year of age on the day of the test. To earn the **Coursing Ability (CAT)**, a dog running alone must pursue a lure, completing the course with enthusiasm and without interruption within a given time. Dogs that pass the CAT three times will earn a Coursing Ability (CA) title. Ten passes and a dog earns a Coursing Ability Advanced (CAA) title, and 25 passes results in a Coursing Ability Excellent (CAX) title.

**FAST CAT** – The FAST CAT is open to all breeds, and Canine Partners at least one year of age on the day of the test. It is a 100 yard timed event, dogs run singly. Dogs earn points towards their titles based on their size and speed, and the Top 20 fastest dogs of each breed are posted on the AKC website.

**NOTE:** Exhibitors will be given the option of having a catcher at the end of the track, or having the dog continue to chase the lure back to the beginning (total about 250 yards).

## FACILITY

The field is NOT fenced, but is well contained within the park, adjacent to the main park road. A reliable recall is recommended. Lunch is not available from the club, but there is a snack booth in the park, or a fabulous sub/pizza shop just outside the entrance.

## CONDITIONS

- Hounds must be 1 year of age or older on the day of the Trial or Test.
- Bitches known to be in season should NOT be brought onto to the test/trial grounds.
- Bitches in season, hounds with AKC breed disqualifications and lame hounds will be excused and the entry fee refunded.
- Hounds not present at roll call will be scratched after a five-minute grace period.
- Gas powered, continuous loop lure system will be used. Backup equipment will be available. The lure will consist of white plastic strips and/or fur.
- A \$10.00 fine will be assessed for any hound loose or interfering with the course in progress.
- A \$25.00 fine will be assessed to any owner not cleaning up after their hound.
- Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee, and may be subject to a bench committee hearing.
